2. Observation of Trial in two Civil and two Criminal cases.
3. **Moot Court:-**

Akbar Ali Khan (the appealing party) who was a lawyer by profession, married to Fatima Begum (the respondent) in 1991, had three sons and two daughters from this marriage. In 1999, when Fatima's age was 30 years, she was disowned by her husband Akbar after 8 long years of marital relation and was tossed out from her marital home together with her children. In February 12th, 2001, she filed an appeal in the presence of Judicial Magistrate of Barrackpore, because she was abandoned from the maintenance of Rs. 2500 per month, which was guaranteed to be provided by him. She demanded Rs. 5000 per month as maintenance. Subsequently, Akbar gave her irrevocable Triple Talaq on November 6th, 2001, and used it as a defence to not pay maintenance. The Magistrate, in 4th of August, 2002 directed the husband to pay an entirety of Rs 2000 per month as maintenance. Fatima Begum in July 2010 made a plea to the High Court of Calcutta, to enhance the sum of maintenance to Rs. 10,000 each month, and High Court increased the maintenance to the claimed amount of Rs. 10,000 per month. The decision by the High Court was challenged by the spouse, Akbar within the Supreme Court as a Special Leave Petition to the High Court's decision.

Issue:-

- a. Whether Section 125,127 of CrPC will overrule the personal laws?



- b. Whether the State has any rights to decide about maintenance between two individuals?
- c. Will it be very discriminatory and will it violate the rights and social status of women?
- d. Does it amount to gender discrimination?
- e. Does not granting maintenance and abiding by these laws violate the Constitutional supremacy and basic principles of our Constitution?
