<u>Important Guidelines for Admission to 5-Year B.A.LL.B. Course – 2025</u>

All candidates seeking admission to the **5-Year B.A.LL.B. Course (Session 2025)** are hereby instructed to carefully read and follow the guidelines mentioned below. Non-compliance with any of these may lead to cancellation of candidature or admission.

1. Submission of Correct Information and Documents

Candidates must ensure that all information and documents submitted during the admission process are **true and authentic**.

2. Responsibility for Incorrect Information

If any information or document submitted by the candidate (or on their behalf) is found to be **incorrect**, **false**, **or misleading**, the **candidate will be solely responsible** for the consequences, including **cancellation of candidature or admission** to the 5-Year B.A.LL.B. Course.

3. Reservation Category Certificates

Candidates applying under SC, ST, OBC-A, OBC-B, PWD, or EWS reservation categories must submit valid certificates/documents issued by competent authorities as per Government Rules and Orders. These documents must be

produced during online form fill-up and at the time of physical document verification, as required by the University of Calcutta or the College.
